

Hi Jesse-

This information actually needs to be submitted as part of your Lease Modification application package. We need the data from the samples, including the fact that there was not enough water to sample during 3rd guarter to be included in Chapter 7 as part of the documentation to support the rule requiring baseline data collection on the lease expansion areas. Also, we don't add monitoring locations to our database until the application has received final approval. At that point you'd be able to go back and add the sampling that was done as part of baseline data collection.
